Is responsible for recording the results of all votes.

D)

Treasurer- to keep all financial records of the BBSC. Collect annual dues and initiation fees. Receive and dispense BBSC funds as authorized by the membership and the executive board. It is the treasurer's responsibility to present a detailed financial report of the previous month's financial activity in the form of a hard copy to be viewed by the membership and to be published with the minutes of the meeting.
